FEE POLICY

Crete Gymnastics Club Training Fees

1. The Crete Gymnastics Club (CGC) charges an annual Training fee per gymnast.
2. The Training fee is revised in October each year, for the following year, by the management committee.
3. No gymnasts will be allowed in the training hall if accounts remain unpaid 30days +.
4. The Training fee is charged in 12 equal installments from 1 January to 1 December.
5. Fees are due no later than the 25th of each month IN ADVANCE.
6. Gymnasts with outstanding fees can not enter competitions.
7. Cancellation of Membership must be done in writing and 1 month's notice must be paid to CGC. If no written cancellation is received, monthly charges will apply as normal.
8. Unpaid accounts will be handed over for collection on a scale as between attorney-own-client.
9. I/we consent that should any legal proceedings arise out of or in connection with unpaid accounts, proceedings shall be brought in the Magistrate's Court having jurisdiction over the area in which I/We reside notwithstanding that the amount or matter in dispute may exceed or fall outside the jurisdiction of such Magistrate's Court.

Additional Payments

1. **Federation / Association registration fee:**
 - Due in January each year. (to be advised)
 - This fee registers the gymnast with the Federation / Association
 - This fee ensures that gymnasts can participate in regional and national competitions.
2. **Competition fees**
 - Each competition that the gymnast wishes to enter, has an entrance fee. Should your account be in arrears, CGC may set off competition fees against outstanding fees on the account, which will void participation for the Gymnast.
 - The Registration fee for all Championships will be advised well in advance.
3. **Uniform**
 - Gymnasts are required to wear CGC uniforms for competitions.
 - Gymnasts can not enter competitions without the CGC uniform.
 - Orders for uniforms are placed in April each year, as it has to be custom made for the club.

Crete Gymnastics Club undertakes to

1. Provide quality training by qualified coaches.
2. Train children according to the guidelines as set out and revised by the FIG (International Gymnastics Federation)

REGULATIONS POLICY

1. Gymnasts are requested to come and practice in comfortable clothes, like shorts and T-Shirts. No pants hanging over the knees are allowed as this restricts movement. No jeans are allowed, as they can damage the equipment.
2. We request that parents are **not** in the hall during practice times, as this divides the attention of the gymnasts. We have Parent-days scheduled and will inform you of them in good time. This is NOT applicable for FUNGYM Gymnasts.
3. All competing gymnasts need to have: A Crete Tracksuit, a Crete T-shirt and a leotard for competitions. We will order the leotards according to your specifications. Tracksuits are available at Boundry Wholesale. We will hand out the necessary Order Forms and Prices in April. Please return this form to us. Closing Date for Orders will be the end of April. (Gymnasts not competing in competitions are welcome to order clothing as well, should they wish to.) NO Gymnast will be allowed to compete without the proper attire.
4. All competing gymnasts need to qualify at 2 Qualifying competitions scheduled throughout the year to participate at Nationals. These competitions are compulsory. Only gymnasts who have participated at both Qualifying Competitions and who received the average qualifying mark are selected by the Gymnastics Federation Namibia to participate at Nationals.
5. ACCOUNTS: Accounts are payable in advance by the 25th of each month. Gymnasts with outstanding accounts will not be allowed to compete at any competitions and will also not be allowed to train, until arrears are settled in full. Please take note that January and December are payable too. No account queries will be discussed during Training Times. Cancellation of Membership needs to be done in writing via e-mail.
6. Gymnasts are requested to bring some Water to their Practice sessions and to do so in a Bag, which can then be used to put in additional clothing or shoes - we try and keep the Hall tidy and prevent personal belongings to get left behind.
7. NO FOOD is allowed in the Practice Area.
8. Gymnasts are only allowed onto the Apparatus in their own practice times and with the supervision of an assigned coach. Children in the hall, not registered with CRETE are not allowed onto the Apparatus. Once gymnasts have completed their Training session, they will not be allowed onto the Apparatus.

10. **LATE COLLECTION FEE:** Parents will be billed N\$ 100.00 per hour if Gymnasts are not collected after their respective classes. Coaches cannot look after the Gymnasts who are not busy with Training at the same time as coaching another class. We appreciate your understanding in this regard.
